[24 Republicans and ALL Democrats fund Transgender Surgeries](#)

Sadly we lost a battle in Congress Thursday, when all Democrats were joined by 24 Republicans who voted NO to defeat the Hartzler Amendment that would **ban the waste of taxpayer dollars on "transgender" surgeries** and hormone injections (estrogen for men).

The bill would have diverted precious hospital treatments from war-injured troops to mentally confused troops who abuse the military for their own gay agenda.

[Congress may defund Transgender Surgeries in DoD](#)

Thursday the House of Representatives voted on a proposed floor amendment to the NDAA that would defund tax-payer funded sex-change operations in the Department of Defense. Christian Congresswoman Vicki Hartzler was fighting for common sense.

"The Hartzler amendment...**prohibit[s] the use of taxpayer dollars to pay for gender re-assignment surgery** and hormone therapy within the TRICARE system," [reports](#) CMR.

The amendment said: "Funds available to the Department of Defense may not


be used to provide medical treatment (other than mental health treatment) related to gender transition to a person entitled to medical care under chapter 55 of title 10, United States Code."

Why was this amendment needed?

"The DoD transgender policy immediately **required the American taxpayers to begin paying for gender transition surgeries**, cross-sex hormone therapy, and other medical care related to gender transition.

"Internal estimates indicate that this policy could cost the military \$1.35 billion in surgery alone over the next 10 years. This number does not account for hormone treatment or medical complications.

"Individuals undergoing **transition surgery are non-deployable** for up to 238 days. This will result in 4,406 non-deployable work years due to surgery recovery alone over the next 10 years. This does not include hormone therapy requirements and the inability to serve in certain career fields, such as nuclear duty or as aircrew.



"According to the Centers for Medicare & Medicaid Services, there are not enough clinical studies to conclude that gender re-assignment surgery is beneficial."
